The Narcotics Control Bureau (abbr. NCB) is an Indian central law enforcement and intelligence agency under the Ministry of Home Affairs, Government of India. The agency is tasked with combating drug trafficking and the use of illegal substances under the provisions of Narcotic Drugs and Psychotropic Substances Act.

Established in 1986, it is responsible for coordination with the Indian state governments and other central departments, implementation of India's international obligations with regard to drug trafficking, and assisting international and foreign drug law enforcement agencies.

Substance abuse has become a significant concern in contemporary times, depriving young minds of their most productive and promising years. It is imperative to cultivate a supportive environment in schools, families, and communities to mitigate the risks associated with substance use and to promote a culture of overall well-being and development.

Substance abuse, also known as drug abuse, is the use of a drug in amounts or by methods that are harmful to the individual or others. It is a form of substance-related disorder. Differing definitions of drug abuse are used in public health, medical, and criminal justice contexts.

In collaboration with NCB, CBSE is organizing an Awareness Campaign against substance abuse for students at Modern School, Vasant Vihar,New Delhi, on 28 August 2024 (Wednesday). Senior Officers from both NCB and CBSE would attend the event, which will focus on educating and engaging students and the broader school community on combating substance abuse and promoting a drug-free lifestyle.
