

Sub:- Issue of Essentiality Certificate under Rule 44 of the
Delhi School Education Act & Rules, 1973.

Sir,

With reference to your application on the subject noted above, I am directed to convey the permission of the Director of Education, Delhi to your Society to start a school in Gautam Nagar area of District South from classes I to XII subject to the following terms and conditions:

1. That the provision of the DSEA, 1973 and Rules framed thereunder shall be observed by the Society.
2. That the Management of the school will fulfill all the conditions laid down under Rule 50 and provide all the facilities given in Rule 51 of DSEA, 1973 to the institution.
3. That the Management of the school will get the scheme of management approved from the Department immediately.
4. That only qualified and trained teachers will be appointed and prescribed Govt. scales alongwith all allowances will be paid to the teaching and non-teaching staff through crossed cheques.
5. That the school will not run for the profit of any individual association or group of persons.
6. That the management of the school will not ask for grant-in-aid from the Department.
7. That in case at any time the management of the school is unable to run the school, moveable and non-moveable property of the school will be transferred in the name of the Director of Education, Delhi.

8. That the management of the school will apply for grant of recognition of the school under the DSEA & Rules, '73 separately, within three years.

That all the recognised classes shall be run at one place only.

10. That the proposed school should be started only after the construction of proper school building on proper sized land duly allotted by D.D.E. through Department in or near Gautam Nagar, New Delhi, within a period of 3 years from the date of issue of this letter (S.C.) and adequate and sufficient accommodation of 12 sq. ft. per student shall be provided for class rooms. The normal size of a class room is 24' x 30'.

If recognition for the proposed school is not sought after fulfilling the above conditions within a period of 3 years, this permission to open a new school, should be treated as cancelled.
